- Third Reading
- 2021-25 A Resolution authorizing the Mayor to enter into a contract with the City of Fairview Park, Ohio for the purpose of providing the City of Fairview Park jail services for housing of Fairview Park prisoners in the North Olmsted City Jail.
- 2021-26 An Ordinance amending Section 3 of Ordinance No. 2002-103, as later amended by Ordinance Nos. 2002-154, 2008-155, 2013-98 and 2017-59, which collectively established fees and charges for emergency medical services rendered by the City of North Olmsted Fire Department, in order to increase fees and charges currently charged.
- 2021-27 A Resolution authorizing the Mayor to accept a donation of a Lifepak 15 Monitor/Defibrillator from University Hospital Systems, St. John Westshore Hospital, for use by the City of North Olmsted Division of Fire.
- 2021-28 A Resolution authorizing the Mayor to advertise for bids for the award of a contract to provide for plumbing and related improvements at the North Olmsted Police Station, as detailed in the specifications on file with the Service Department; and further authorizing the Mayor, following approval of the Board of Control, to contract for the same with the lowest and best bidder.

- 2021-31 A Resolution authorizing the Mayor to advertise for bids for the award of a contract to lease replacement fitness/cardio equipment at the North Olmsted Recreation Center, as detailed in the specifications on file in the Division of Recreation, and authorizing the Mayor, following approval of the Board of Control, to contract for the same with the lowest and best bidder.

- 2021-32 A Resolution amending Resolution 2021-11 to extend the deadline for application submission for financial assistance from the Small Business Relief Program in the City of North Olmsted, and declaring an emergency.
- 2021-33 A Resolution authorizing the Mayor to purchase one (1) new 2022 model HV507 Salt Truck from International at a cost of \$77,424.00, together with the purchase of ancillary hook lift hoist snow & ice control equipment from Concord Road Equipment at a cost of \$130,730.04, both through the State Purchase Program; and further authorizing the Mayor to execute all contract documents, and declaring an emergency.
- 2021-34 A Resolution authorizing the Mayor to enter into a “Software as a Service (SaaS)” agreement with Tyler Technologies to provide cloud-based hosting and related computer services, and declaring an emergency.
