#### Residential Plumber Dye Tests Checklist

Upon receipt of this completed form and the review of the dye test information provided by the plumber is reviewed is conducted by the City of North Olmsted. All violations, open permits, and dye testing requirements must be resolved before any Notice of Violation (NOV) is released.

An extension to any deadline (temporary relief from compliance) may be made to the department in the event of a failed test. However, all written requests should be submitted (3) business days before the expiration date of the NOV.

**The City of North Olmsted will not perform a dye test to resolve an NOV.**

THE PLUMBER YOU SELECT MUST BE REGISTERED AND LICENSED IN BY THE CITY OF NORTH OLMSTED

Testing must include, but is not limited to any of the following:

- Dye-testing at each downspout
- Dye-testing at driveway and area drains
- Dye-testing by flooding negative slope driveways with fresh-air vents at the base of the driveway (surface water should be captured by an area drain and not the vent)
- Dye-testing at each roof drain on flat roofs where the rain leader is enclosed within the structure
- Dye testing of any interior sump pump
- Dye testing any footer tile by use of dye and soaking the foundation for no less than 30 minutes
- Dye-testing at exterior French drains or exterior sump pump

THE COMPLETED DYE TEST FORM AND FEE MUST BE RETURNED TO THE

ATTENTION OF THE NORTH OLMSTED WASTEWATER DEPARTMENT AT LEAST 3 BUSINESS DAYS BEFORE THE CLOSING DATE OF THE NOV.
