

## LEGAL ADVERTISEMENT

Sealed bids will be received by the Director of Public Service of the City of North Olmsted until 1:00 PM, Local Time on the **14<sup>th</sup> of September 2022**, for **WWTP Administration Building -Training Room Improvements**, in accordance with Resolution No. **2022-61** and in accordance with plans and specifications on file in the Engineering Dept. The bid must be submitted on the forms available in the Building Dept., at City Hall, 5200 Dover Center Rd, North Olmsted, Ohio, and each bid must state the full name and address of each person, firm or corporation interested in the bid submitted. **A pre-bid meeting will be held at the Administration building of the North Olmsted Waste Water Treatment Plant on Sept 6th at 1:00 PM.**

Bids must be submitted in a sealed envelope and clearly marked with the Bid Resolution Number, opening date, and item being bid. In the event that several invitations are being bid simultaneously, each bid must be submitted in a separate envelope. Bids must be delivered directly to the City of North Olmsted City Hall, 5200 Dover Center Rd, North Olmsted, Ohio, 44070, prior to 1:00 PM, Local Time, of the day of the bid opening.

Each bid for each project must be accompanied by a certified check on a solvent bank in the amount of 10% of the bid or a 100% Bid Bond, the same being payable to the City of North Olmsted as a guarantee that, if the bid is accepted, a Contract will be entered into and a Performance Bond satisfactory to said municipality in an amount equal to 100% of the total bid will be furnished. The deposit of the successful bidder will be retained until the Contract is properly executed and delivered. Deposits of all unsuccessful bidders will be returned following the award.

Copies of the specifications, bid forms, drawings, and other contract documents are on file at the Building Department and may be obtained in person between the hours of 9:00 a.m. and 4:00 p.m., upon depositing a check for **twenty dollars (\$20.00)**, made payable to the **CITY OF NORTH OLMSTED**. **The deposit(s) will be non-refundable. NO plans or specifications will be mailed.** Questions regarding the bid shall be directed in writing to the Engineering Department.

The City reserves the right to accept all or any part of any bid and to reject any and all bids, and to waive any informality in the bids received, and to accept any bid, or combination of bids, which it deems lowest and best. **Bidders shall be a planholder of record with the City in order for their bid to be considered.**

The City of North Olmsted is an Equal Opportunity Employer and does not discriminate against the physically impaired. Each bidder must ensure that all employees and applicants for employment are not discriminated against because of their race, creed, color, sex or national origin.

Bidders must comply with prevailing wage rates on public improvements in Cuyahoga County and the City of North Olmsted, Ohio as determined by the Ohio Bureau of Employment Services.
